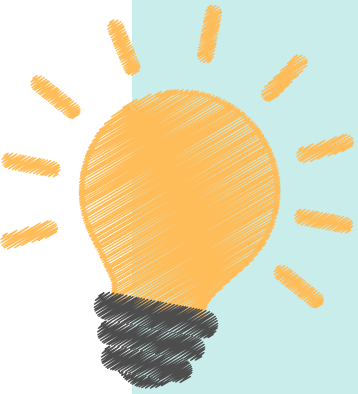

## WHY DID WE DEVELOP THIS TRAINING?



Janet has cancer. She has no children and her husband, as he explained, did not know how to care for Janet's increasing support needs.

Janet is a Health Policy Consultant, and she came to us to develop a program that would help her husband and the millions of other unpaid informal Caregivers increase their practical caregiving skills and decrease their stress in providing this essential care. So that is what we did.

When the training was piloted, Janet's husband was the first to register.

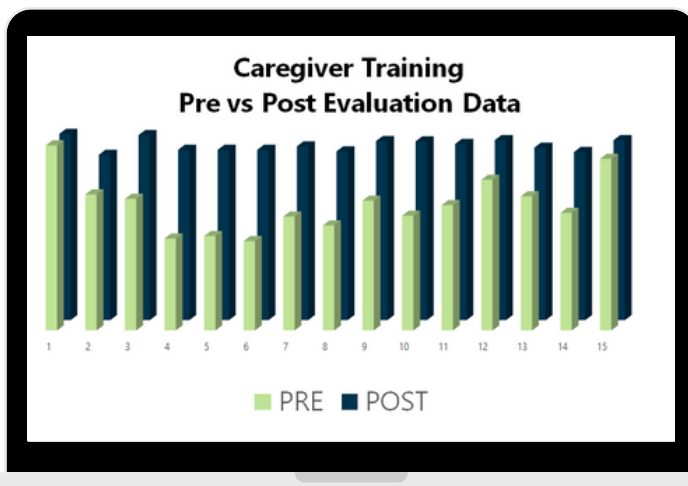

## DATA SHOWS...

An increase in self-reported confidence levels over all 11 modules of the program.

Participant evaluation data has been used to refine content over 7 rounds of training conducted over 2 years.

# OVERVIEW OF THE PROGRAM

The Champlain Hospice Palliative Care Program is committed to helping as many Caregivers as possible to receive this training and will help your organization with training, materials and implementation.

**All material is completely free** and made available to organizations to use in their regions, as long as the training is provided free of charge.

Practical Caregiver Training covers 11 modules. The modules are independent of each other and can be rearranged to work with each organization's objectives and needs; however we have found that a 5-week (2 hours per week) format has worked best for the Caregivers we have trained. We recommend no more than 12 Caregivers in each cohort.

## WHAT WE PROVIDE

We are happy to provide all electronic materials to you for free, including:

- All PowerPoint Slides with Speakers Notes
- A Facilitator Guide with explanations of all activities
- A Participant Guidebook which acts as a workbook
- Evaluation Templates

This training was originally designed to be in-person. However, we have adapted the material to a virtual format. Whether you decide to run an in-person program or a virtual program, we can provide more detailed lists of required materials (for example, a secure video conferencing platform).

## HUMAN RESOURCES

Practical Caregiver Training is unique in that Caregivers have access to live instructors, and can ask their questions in real-time.

Required instructors include:

- **A Program Facilitator**
  - Qualifications: An ideal facilitator is someone who is comfortable facilitating groups, discussing issues related to illness, dying, death and grieving and has knowledge of palliative care and community supports and services.
  - Connecting with registrants before, during and after the training
  - Following up on any questions
  - Filling out the "Caregiver Needs Map" for each participant
  - Teaching Week 1 and 5
  - Supporting facilitators for Week 2, 3 and 4.
  - You may choose to divide this role between 2 persons. 1 of the persons can care for all the administration and the other person can care for facilitation). However, we have found it effective to designate just one person so the participants build a strong connection.
- **A Physiotherapist or Occupational Therapist**
  - Qualifications: Experience working in a palliative environment
  - Teaching Week 2
- **A Palliative Nurse**
  - Qualifications: experience working in a palliative environment
  - Teaching Week 3 and 4

## COSTS ARE ADAPTABLE

Whether you choose to run a virtual or live training, **the costs can be adjusted based on the resources your organization already has access to.** For example, if you have access to a virtual platform, then those line items would be set to 0.00\$.

Costs can be further adjusted by what physical resources you provide to the participants (for example, if you provide a "Caregiver Guide" booklet or not).

The program is very flexible, and adaptable to what you can offer. The CHPCP is happy to help you find ways to adjust costs, so you can run this valuable training.

## BUDGET FOR VIRTUAL TRAINING

**The following budget assumes you have no internal resources available.**

### Virtual Platform

- Virtual Platform Account for 2 Months
  - Zoom Platform = 40\$ for 2 month committment

### Human Resources

- A Program Facilitator
  - Including Program Coordination before, during and after session
  - Including facilitation of Week 1 and Week 5 of Training
  - Average of 30\$ per Hour, Average of 30 hours of work = 900\$
- A Physiotherapist/Occupational Therapist
  - Including facilitation of Week 2
  - Average of 100\$ per Hour. Average of 2.5 hours of work = 250\$
- A Palliative Nurse
  - Including facilitation of Week 3 and Week 4
  - Average of 100\$ per hour. Average of 5 hours of work = 500\$

### Materials

- Printing of Participant Guidebook
  - Average of 12 Guidebooks = 170\$
- Caregiver Guide
  - Average of 12 Guides = 40\$
- Postage
  - Average of 12 packages = 100\$

**Total Costs with No Internal Resources: 2000\$**

Average of Most Organizations to Run the Program: **1000\$**
